## **Upcoming public meeting on the *Regulatory Oversight Report for Canadian Nuclear Laboratories (CNL) Sites: 2018***

The Canadian Nuclear Safety Commission (CNSC) announces a change in date and location for the public meeting during which CNSC staff will present the *Regulatory Oversight Report for Canadian Nuclear Laboratories (CNL) Sites: 2018* (ROR). The ROR will now be presented during the **November 6–7, 2019** Commission meeting, which will be held in **Ottawa, Ontario**.

The ROR will provide CNSC staff's assessment of the safety performance of CNSC-licensed CNL sites, namely the Chalk River Laboratories site; the Douglas Point Waste Facility; the Gentilly-1 Waste Facility; the Nuclear Power Demonstration Waste Facility; the Port Hope Area Initiative (consisting of the Port Hope and Port Granby projects); and Whiteshell Laboratories. The ROR will also include information on future developments at these CNL sites and on areas of particular regulatory focus for the CNSC.

The public meeting will be webcast live and available on the CNSC website at [nuclearsafety.gc.ca](http://nuclearsafety.gc.ca).

In advance of the public meeting, the CNSC is making available up to **\$50,000** in funding, through its [Participant Funding Program](#). The purpose of the funding is to assist Indigenous peoples, members of the public and stakeholders in reviewing the ROR and participating in the Commission meeting process by providing topic-specific submissions to the Commission. Please note that the \$50,000 will be disbursed among all successful applicants. The deadline for submitting a completed participant funding application form to the CNSC remains **May 17, 2019**.

The draft ROR will be available for review on the CNSC website, or on request to the Secretariat, after **September 6, 2019**.

Persons who have an interest or expertise in this matter are invited to comment on the ROR in writing by **October 7, 2019** using the [online request form](#) or the contact information below. The submission must include your name, address and telephone number. In addition, the CNSC will allow Indigenous intervenors the opportunity to make oral presentations in the spirit of reconciliation and in recognition of the Indigenous oral tradition for sharing knowledge.

All submissions will be available for download on the CNSC website, or on request to the Secretariat. Personal information, such as address and telephone number, is essential for linking the submission to its author.
